

Privacy Policy - Introduction:

In this document "the dental practice" refers to "Four Oaks Dental"

This Privacy Policy outlines how Four Oaks Dental Practice ("we", "us", or "our") collects, uses, and safeguards personal information in accordance with the General Data Protection Regulation (GDPR) and the Data Protection Act 2018. This policy applies to all individuals who provide personal information to the dental practice, including patients, employees, and contractors.

Collection of Personal Information:
